Please be aware for your planning purposes that Environmental Health has received authorization for additional county fees to help us provide the required services to our regulated facilities. The last time we added any fees was 2011, and costs have obviously increased. The most obvious fees that all facilities will see is a \$50.00/inspection fee.

The fees have been approved by the Board of County Commissioners, so we wanted to let you know this is on the books. These fees will take effect October 1, 2023.
